## **PUBLIC HEARINGS:**

1. To consider a draft ordinance amending Title 7, Animals, amending setback requirements associated with the keeping of bees.
2. To consider a draft ordinance amending Chapter 20.15 of the Bellingham Municipal Code to allow up to three renewals of one year each for temporary tiny house encampments provided that conditions are met.
3. To consider a draft ordinance amending sections of Title 20, Land Use Development, to remove limitations on the number of unrelated people who may live together in a dwelling unit per state law.
